



Trader and Recipient request and declaration

Request to bring goods from NL into conformity in another Member State (MS)

The goods listed below do not comply with the standards of Regulation (EU) no. 2023/2429. The Dutch KCB inspection body has issued a non-conformity finding, addressed to the trader or their representatives.

Only goods complying with the standards of Regulation (EU) No. 2023/2429 may be traded and marketed on the EU market. Fruits and vegetables for which a non-conformity finding, has been issued in the Netherlands may not be moved without prior authorisation of the KCB.

This request form, to bring goods into conformity in another MS, must be send to the KCB head office by e-mail: notifications@kcb.nl and district office concerned.

Article 10.3 of Regulation EU no. 2023/2430 - Request

As stated in article 10.3: the trader / FBO* (Nr.1 mentioned below) and the recipient (Nr.15 mentioned below) wish to bring the goods listed below into conformity in the MS of destination listed below under Nr. 15. The recipient shall notify the inspection body of the MS of destination of the non-conforming lot. The KCB shall send a copy of the non-conformity finding**, to the MS of destination as well as to other MS concerned when necessary.

Trader and recipient shall provide all information required for this application to bring goods into conformity in another MS. Recipient FBO (Nr.15 mentioned below) declares:

- 1. to notify the competent inspection body of the MS of destination of the non-conforming lot prior to departure (with this form, a copy of CMR, including information on the date and location of arrival);**
- 2. to bring the goods into compliance with the EU standards;**
- 3. to present the goods, once brought into conformity, for a conformity check at the competent inspection body;**
- 4. to complete point 1, 2 and 3 before custom clearance.**
