



Trader and Recipient request and declaration

Request to bring goods from another Member State (MS) into conformity in the Netherlands

The goods listed below do not comply with the standards of Regulation (EU) No. 2023/2429.
An EU inspection body has issued a non-conformity finding, addressed to trader or their representatives.

Only goods complying with the standards of Regulation (EU) No. 2023/2429 may be traded and marketed on the EU market. Fruits and vegetables subject to a non-conformity finding, issued by a Member State's inspection body may not be moved to the Netherlands without prior authorisation from the KCB.

This request form, to bring goods into conformity in the Netherlands, must be sent by a company and/or the EU inspection body to the KCB head office by e-mail: notifications@kcb.nl.

Article 10.3 of Regulation EU No. 2023/2430 - Request

As stated in article 10.3: the trader / FBO* (Nr.1 mentioned below) and the recipient (Nr.15 mentioned below) wish to bring the goods listed below into conformity in The Netherlands. The recipient shall notify the KCB of the non-conforming lot. The Member State issuing the finding of non-conformity shall send a copy of that finding** to the KCB in The Netherlands as well as to other Member States concerned.

Trader and recipient shall provide all information required for this application to bring goods into conformity in the Netherlands. Recipient FBO (Nr.15 mentioned below) declares:

- 1. to notify the KCB of the non-conforming lot prior to departure to the Netherlands (using this form, a copy of CMR, including information on the date and location of arrival);***
- 2. to bring the goods into compliance with the EU standards;***
- 3. to present the goods, once brought into conformity, for a conformity check at the relevant KCB district office;***
- 4. to complete point 1, 2 and 3 before declaring the goods in CLIENT Import and before custom clearance.***
